# COMMERCIAL WASTE SERVICES

## Terms & Conditions

- Disposal or recycling of waste generated from any type of profit-making activity, including that conducted from commercial premises, market stalls, home and vehicle-based businesses, is chargeable at the rates overleaf at these 10 Recycling Centers, below.
- The deposit of any type of construction or demolition waste (including hardcore & soils) and any waste transported on behalf of a third party for profit, will require you to hold a "Waste Carrier License". If you do not have a "Waste Carrier License", you will be permitted to dispose of your waste on up to five occasions to allow you sufficient time to apply for a license, after which access will be denied.
- All waste must be accurately described and only waste types detailed overleaf are permitted at these facilities.
- On every visit, site staff will provide you with the necessary waste transfer notes (duty of care) and receipts for the transaction after payment has been made by credit or debit card.
- All vehicles and persons using the site are expected to adhere to Visitor's Health & Safety policy, (Please ask Biffa staff for further details).
- Customers are responsible for supplying their own personal protective equipment & clothing. Customers MUST take reasonable steps to protect themselves, their employees and other users of the facilities.
- In case of a dispute, customers should contact the site manager. The site manager will have the final decision about whether to accept the waste and what charges will be applied at that time. Should there be any issues regarding the site manager's decisions, the pricing structure or how the facilities are being operated, customers should call Biffa on 01823 324088 after they have left the site. If you consider that the issue has still not been appropriately resolved, customers should contact Somerset County Council on 0300 123 2224 or email somersetdirect@somerset.gov.uk.
- These sites are operated by Biffa Ltd. All site staff working at these facilities are direct Biffa employees.
